By using JetPay electronic and online services (“Electronic Services”) you hereby consent to this Notice and affirm that you have access to the hardware and software requirements identified below. If you do not consent to this Notice or you withdraw your consent, you will be restricted from using Electronic Services and will be charged fees for paper notices, as described on the JetPay Terms and Conditions on the JetPay Money Access Card website.

COVERED COMMUNICATIONS

May include, but are not limited to, disclosures and communications we provide to you regarding our services such as: (i) terms and conditions, privacy statements, notices, and any changes thereto; (ii) deposit and transaction information; and (iii) customer service communications (“Communications”).

METHODS OF PROVIDING COMMUNICATIONS

We may provide Communications to you by email, text message, or on the JetPay websites, mobile applications, or mobile websites (including via “hyperlinks” provided online, in e-mails, or in text messages).

HARDWARE AND SOFTWARE REQUIREMENTS

To access and retain electronic Communications, you must have:

- A valid email address or mobile phone number;
- A computer, mobile phone, tablet or similar device with internet access and current software or applications that are capable of receiving, accessing, displaying, and either printing or storing Communications received in electronic form;
- Sufficient storage space to save Communications (whether presented online, in e-mails, in text messages or PDF) or the ability to print Communications.

We may request that you respond to an email or text message to demonstrate you are able to receive these Communications.
